

PARENT / LEGAL GUARDIAN PERMISSION AND RELEASE FORM

In order to comply with Federal and Ohio law and to promote a safe facility, AimHi requires that all individuals must be at least <u>21</u> years old to handle or shoot an handgun and at least <u>18</u> years old to handle or shoot a long gun without being accompanied and supervised by a responsible adult at all times. In instances where responsible adult supervision is required, the adult must either be the parent or legal guardian of the minor or have provided AimHi with this permission and release form signed by the parent or legal guardian.

I have read and agree to the terms of the *Assumption of Risk, Waiver of Liability and Indemnity Agreement* and to the maximum extent permitted under law, agree that such terms shall apply to the above-named minors, myself, my next of kin, heirs, guardians, representatives, and assigns, and without limiting the foregoing, I herby agree to indemnify and hold harmless AimHi and all of its employees and staff, agents, representatives, officers, directors, and shareholders from any and all liability arising out of or relating to the negligence, willful misconduct or any other act or omission of the above-named minor(s) or the above-named responsible adults. If any provision of this release is held to be invalid, contrary to law, void or otherwise unenforceable, then such provision shall not void or render unenforceable any other provision of this release and the remaining provisions shall continue and remain in legal force and effect.
